

2011 / 2012 TUITION and ILLNESS AGREEMENT

A separate Tuition and Illness Agreement is required each school year for each child enrolled at Premier Academy.

TUITION AGREEMENT

1. I understand that this Tuition Agreement is a legally binding contract for payment in full of my child's full yearly tuition amount to Premier Academy, Inc.
2. I understand that when I register my child for either the upcoming or the current school year, the New Student Fee (if applicable) and Enrollment/Supply Fee is neither refundable nor transferable under any circumstances.
3. If I place my child on a Paid Enrollment Waiting List, I understand that this sum is refundable only if Premier Academy cannot place my child in a class within 12 (twelve) calendar months. I understand I must request this repayment from Premier Academy in writing.
4. If my child's tuition payment is received later than the tenth day of any month, for any reason, I agree to pay a late fee of \$50 (fifty dollars) in addition to the fees due.
5. I understand that if I choose to pay my child's tuition monthly, that payments are due for 11 consecutive months beginning July 1 of enrollment year.
6. I agree to furnish Premier Academy with a signed and valid credit card authorization form, and agree that Premier Academy may charge any unpaid balances to this account on the 11th of each month, along with applicable late fee.
7. Should my tuition become delinquent by two weeks, at the sole discretion of Premier Academy, I understand that my child will be suspended from Premier Academy classes and activities until the entire balance and any late fees are paid in full.
8. I understand that Premier Academy students will observe the following holidays and that full tuition is due for the month that includes the holiday: Legal Holidays, Thanksgiving Holidays, Spring Break, Winter Break, Teacher Professional Development Days, and any school day closures due to severe weather conditions.
9. I understand that no financial credit will be given for absences due to illness, or any other reason, including days missed due to severe weather conditions.
10. I understand that days missed due to illness or absence for any reason, including days missed due to severe weather conditions, cannot be substituted for other days.
11. I understand that Premier Academy may offer field trips and optional programs, which may require additional fees in addition to regular tuition. If my child participates, I agree to pay additional fees for any extra programs provided for my child.
12. I agree to pay Premier Academy a \$100.00 fee for any check returned from the bank unpaid for any reason, along with late payment fee if applicable.
13. I agree to pay late charges as assessed if my child remains at Premier Academy past the designated closing time.
14. I understand that the New Student Fee, the Enrollment Fee, and any pre-paid tuition will not be refunded if I remove my child from Premier Academy enrollment any time during the school year for any reason.
15. I understand that my tuition obligation is for the entire yearly tuition amount, and I agree to pay that amount either in one lump sum (due July 1st), or two times per year (due July 1st and December 1st) or 11 (eleven) consecutive payments beginning July 1, 2011.
16. I understand that a discount is given for tuition paid in one or two payments as outlined on the Premier Academy Tuition Schedule.
17. I understand that NO tuition payment is due for the month of June, unless there is a balance carried forward for any reason. I understand I am liable for any lunches / StayDays / Extra Days / and Early Drop Off fees incurred during this period.
18. I agree, by signing below that I will be personally responsible for all fees for the child named below.
19. I understand that if my child arrives at school without a lunch for any reason, Premier Academy may order my child a lunch, and I will be responsible for payment.
20. Premier Academy may use photographs and/or videos of my child for newspaper articles, brochures, and other publicity purposes, and I understand that Premier Academy owns all rights to such video and/or photographs.
21. I agree to pay my child's yearly tuition (please check one option below):

**ILLNESS AGREEMENT**

I understand that I will be notified should my child become ill while at Premier Academy, and I agree to take my child from Premier Academy after such notification. I understand that I may not bring my child to Premier Academy ill.
